

- Impact Mapping + Program Model Activities
- Drafting Your Grantee-Led Evaluation Learning Questions

ALIGN Template Feedback

- 1 Well-defined outcomes and actionable learning questions.
- Clear and logical organization with thorough detail throughout templates.
- CDPHE Evaluation changes impacted key evaluation concepts and definitions originally shared.
- A renewed focus on Policy and Systems Change.
- Opportunity for more specificity in the scope of Evaluation Questions

Key things to know about CDPHE Priority Metrics

- **CDPHE** Priority Metrics:
 - Informed through your Grantee Evaluation Questions
 - Used to collect (and align) key data for the CDPHE HDCGP Grant Program Cluster Evaluation and your Grantee Led Evaluation
 - Not all metrics will be relevant to every project (e.g., if your focus is on strategic documentation, reporting on "Priority Populations Directly Served" may not be relevant).
 - Collected through ongoing RedCap Progress Reports.



Measurement Plan

What is a measurement plan?



A measurement plan outlines **WHAT** you need to know and **HOW** you will collect the data. This provides you with a plan to guide your data practice. This can also be called a *data plan*, *results framework*, or *evaluation plan*.

Who & Implementation

- Number of participants by key demographics
- Number/type of program activities, participant experiences
- Dosage and duration of program components
- Satisfaction with experiences; program activities
- Quality of experiences;
 program activities

Outcomes

- Participants: Changes in mental models, knowledge, practices, attitudes, beliefs
- Policy and Systems (PS): Changes in networks, policies, access, resources, infrastructure, Number of new initiatives, stage of initiative or policy change
- Social Determinants of Health (SDoH): Count of improvements in individual, family, community behaviors or living conditions, Changes in access, quality and comprehensiveness or equity of medical or non-medical service across social determinants of health
- Health and Health Equity Outcomes (HO/HE): Changes in the health status of individuals or populations, changes in disparities in health outcomes
